

## Helping people with disabilities save for the future

Endowment 150 is available to adult residents of BC who:

Endowment 150 offers eligible people with disabilities a one-time grant of \$150 to help their Registered Disability Savings Plan (RDSP) grow. This \$150 grant, plus grants and bonds available from the Federal Government, will grow and help you save for your future or that of a loved one.

## Who can apply?

□ have	a disability and receive the federal Disability Tax Credit
□ are u	under 60 years of age (if 59, the individual must apply before the end of the calendar year in which he/she turns 59)
□ have	low income (have received income assistance or annual income below \$25,000)
□ have	an RDSP
□ have	not previously received a \$150 grant from Endowment 150
Children wit	h disabilities are also eligible. For details, please see the application form for children.
